We request any “public record” of “Cesar Vallejo College” and its owner César Acuña Peralta (a leading Peruvian politician) in relation to

- 1. Any official license, permission, certificate, public record, rule or right concerning any degree, title, honour or right by “Cesar Vallejo College”**
- 2. Number and qualification of professors at “Cesar Vallejo College”**
- 3. Number of students already admitted at “Cesar Vallejo College”**
- 4. Any sanction, complaint, inspection, incident, in public record known or documented by any official concerning “Cesar Vallejo College”**

In order to explain our priorities, we suggest a serious analysis of the official documents of “**Cesar Vallejo College**” considering what already happened in Peru at the “Universidad César Vallejo UCV” illegally using the name of Harvard College founded by the same owner César Acuña Peralta, as can be seen (in Spanish) in the documents sent to the **Instituto Nacional de Defensa de la Competencia y de la Protección de la Propiedad Intelectual - INDECOPI en la República del Perú en REQUERIMIENTO DE INFORMACIÓN SOLICITUD DE ACCESO A LA INFORMACIÓN PÚBLICA - Atn.
